Denny's Restaurant #138, 233 S 3rd St (**3 Critical, 1 Non-Critical**) Sautéed onions, sliced onions, sliced tomatoes, Pico, French toast batter all found at 47 – 54 degrees in grill area – should be 41 or less; Out-dated Pico found on counter in grill area; Debris on knives in knife rack, soda fountain nozzles found with debris.

Speedway #8533, 2135 Wabash Ave (**2 Critical, 2 Non-Critical**) Handwash sink in kitchen found unclean; No proof of Certified Food Managers course taken and passed.

Royal Mandarin, 901 Lafayette Ave (**2 Critical, 1 Non-Critical**) Egg drop soup and hot and sour soup found at 123 degrees – should be 135 or above; No sanitizer measured in 3-bay sink.

Drury Inn, 3040 US Hwy 41 S (**2 Critical**) Sausage gravy and potatoes in warmer found at 128 degrees – should be 135 or above (corrected); Chicken tenders in cooler not date marked.

First Wok, 2570 Wabash Ave (**1 Critical, 3 Non-Critical**) No sanitizer measured in three bay sink and wiping cloth bucket.

Sonic Drive In, 2149 S St Rd 46 (**1 Critical, 2 Non-Critical**) Black debris observed on drive thru soda nozzles and black debris and lime build up found inside of ice machine.

The Copper Bar, 810 Wabash Ave (**1 Critical, 2 Non-Critical**) Black debris observed inside of ice machine.

Travelodge, 530 S 3rd St (**1 Critical, 2 Non-Critical**) No sanitizer provided.

Rick's Smokehouse & Grill, 3102 Wabash Ave (**1 Critical, 2 Non-Critical**) Pans of smoked pulled pork and chicken breasts held more than 7 days (discarded).
