Chavas Mexican Grill, 669 Wabash Ave., **(4 Critical, 1 Non-Critical)** – Queso cheese sauce, refried beans, rice, ground beef, pork, shredded beef found in walk-in cooler at 55° (discarded), should be 41° or less; bagged rice made 3 hours earlier found at 75° (discarded); container found in handwash sink; Dirty knives found on knife rack.

Stultz Country Store, 4802 US Hwy. 150, **(2 Critical, 2 Non-Critical)** – Flies present throughout, mouse droppings found in drawers; No sanitizer measured in 3-bay sink (corrected).

Logan's Rib-Eye, 100 S. Fruitridge Ave., **(2 Critical, 2 Non-Critical)** – Vegetable beef soup made the night before found in reach in cooler at 59° (discarded); Employee handling sandwich buns with bare hands (corrected).

Circle K #2255, 1280 Lafayette, **(2 Critical, 1 Non-Critical)** – Handwash sink in back room blocked by brooms, trash can, and umbrellas; Hot dog tongs, condiment containers and scoops not sanitized after washing.

Imperial Lanes, 400 N. 3rd St., **(2 Critical, 1 Non-Critical)** – Soda nozzle holder in front bar found with debris; No sanitizer provided.

Fifi's Lunch Box, 2918 Wabash Ave., **(2 Critical)** – chicken broth and macaroni n cheese found at 98° and 75° within 2 hours (discarded); Sliced turkey and roast beef, pork belly and tomato bisque not marked with date of disposal.

Rick's Smokehouse & Grill, 3102 Wabash Ave., **(1 Critical, 3 Non-Critical)** – Chicken wings, bean meat, ham chunks held past date of consumption (discarded).
