The Copper Bar, 810 Wabash Ave., **(8 Critical, 3 Non Critical)**-Chili made in the morning found at 95-110F after cooling in refrigerator after 3 hours (discarded) ; Pizza toppings cooler holding foods at 59F and above, should be kept at 41F or less (foods discarded) ; Garlic in oil mixture found on countertop at room temperature; Employee drink found on salad prep cooler cutting board; No sanitizer measured in dishwasher; Ground beef and taco meat not marked with date of disposal; Italian beef and house made marinara kept longer than 7 days; Inside of ice machine found with black debris. (Closed)

Rod & Gun Club, 2525 E. Lambert, **(4 Critical, 1 Non Critical)**-Potato dicer and saucepan found with food debris; Two bags of rotten raw chicken found in walk in cooler (discarded); Onions stored in bucket previously used for chlorine sanitizer; Raw steaks stored above saucepan of green beans.

Royal Mandarin, 901 Lafayette Ave., **(2 Critical, 4 Non Critical)**-Cooked chicken, beef, and lo mein noodles found on countertop at 58-85F (discarded) should be 41F or less; Sliced pork thawing on wood shelf found at 69F (discarded) should be 41F or less.

Kroger J-987 & Fuel Center, 4714 S US Hwy 41, **(2 Critical, 2 Non Critical)**-Employee drink on clean cutting board in deli; Utensils bucket and deli pans observed with debris.

7th & Elm Bar and Grille, 729 N 7th St., **(2 Critical)**-Foods found in grill cooler at 52F (already corrected); Bar soda nozzles and holder found unclean.

Homey's Que and Grill, 1100 S 13th St., **(1 Critical, 2 Non Critical)**-Small individual containers of Mac and cheese and baked beans found at 125-129-F should be at least 135F.

Taco Casita LLC, 2201 S 3rd St., **(1 Critical, 2 Non Critical)**-Duct tape wrapped around handles of fry baskets, not smooth and easily cleanable.

Moose Lodge #1009, 3708 Wabash Ave., **(1 Critical, 2 Non Critical)**-Debris observed on chute in ice machine.

Pizza Hut Delivery, 1301 Wabash Ave., **(1 Critical, 1 Non Critical)**-Handwash sink in dish area found dirty.

Ryves Hall Youth Center, 1356 Locust St., **(1 Critical)**-No sanitizer measured in dishwasher.
