Ardi's, 2525 Wabash Ave., **(5 Critical, 1 Non Critical)**-Observed cook and waitress handle food with bare hands; Cooked rice found cooling on shelf, not cooled within proper time limits; Shell eggs, hash browns and liquid egg mixture, found at 55-78F chicken and liver breading with clumps in it found at room temperature (discarded); Sliced lunch meat and cooked sausage in cooler by grill not marked with date of consumption; Observed several uncovered employee drinks on prep tables.

Valley Grill, 2170 N 3rd St., **(2 Critical, 3 Non Critical)**-Raw eggs 75 degrees (discarded); Cooked spaghetti in walk-in cooler not date marked.

McDonald's #6131, 3032 Wabash Ave., **(2 Critical, 1 Non Critical)**-Brown debris observed on soda nozzles in dining room; Time marking on cheese incorrect.

Real Hacienda (Wabash), 3728 Wabash Ave., **(2 Critical, 1 Non Critical)**-Utensils found in hand wash sink; No sanitizer measured in automatic dishwasher (corrected).

Olive Garden Italian Restaurant, 3820 S US Hwy 41, **(2 Critical, 1 Non Critical)**-Beverage residue observed in hand wash sink; Spray bottle of cleaner found on top of coffee machine.
