Arby's #7082, 2155 Lafayette Ave., **(2 Critical, 4 Non-Critical)** – Soda nozzles in drive thru and lobby found with black debris; Mesh trays used to cook bacon and for hot holding food found with burnt on grease/food.

Wendy's, 229 S. 3rd St., **(2 Critical, 2 Non-Critical)** – Observed several gnats behind front counter, Shredded cheese found at 58 degrees, should be 41 degrees or less.
