Jiffy Mini-Mart #520, 1900 Margaret Ave., **(4 Critical, 2 Non-Critical)** – Sandwiches in warmer, hot dog chili sauce and sausages on roller found at 96-131 degrees, should be 135 degrees or above; soda fountain nozzles found with accumulated debris; Front handwash sink found dirty; No paper towels provided at handwash sink in back storage room.

Jiffy Mini-Mart, 1560 N. 25th St., **(4 Critical, 2 Non-Critical)** – Observed accumulated black debris on soda fountain nozzles; Found brown residue and ladle in handwash sink; Crock pot for sausage gravy not sanitized; No certified food handler on staff.

Coffee Cup #2, 2919 S. 3rd St., **(3 Critical, 1 Non-Critical)** – Raw meats found in walk-in stored above ready to eat foods (onion, mixed vegetables, sauce), raw hamburger stored above cooked sausage in prep cooler; No sanitizer measured in dishwasher; Employee observed not sanitizing colander after washing and rinsing.

Arby's #1144, 1025 Wabash Ave., **(2 Critical, 0 Non-Critical)** – Observed arby q meat at 101 degrees should be 135 degrees or above; Soda nozzles and spray nozzle at 3-bay sink found with accumulated black debris.

Sushi Umi, 2801 S. 3rd St., **(1 Critical, 3 Non-Critical)** – BBQ eel 60 degrees in display case (discarded).

The Wyndmoor, 1465 E. Crossing Blvd., **(1 Critical, 2 Non-Critical)** – Pink debris observed on ice machine chute.
