

Establishment Inspections

First Wok, 2570 Wabash Ave., **(5 Critical, 3 Non-Critical)** – Found employee drinks with out lids on shelf above open top cooler; Various raw meats in open top cooler found at 50-53 degrees, should be 41 degrees or less; No sanitizer measured in wiping cloth bucket in kitchen; Found dirty knives on knife rack and dirty strainers on shelf above 3-bay sink; Observed tongs in handwash sink and a bowl of raw chicken sitting on top of handwash sink.

The Country Club of Terre Haute, 57 Allendale, **(3 Critical, 4 Non-Critical)** – Caramelized onions, cooked linguini held beyond date of consumption; Breeding under prep table in grill area left from previous shift and observed with food bits; No proof of certified food handler.

Garfield's Restaurant & Pub, 3401 S. U.S. Hwy. 41, **(2 Critical, 1 Non-Critical)** – Soda fountain nozzles in bar observed with debris; Grill tongs observed with accumulation of burnt on debris.

Panera Bread Bakery/Café #1088, 5653 S. U.S. Hwy. 41, **(2 Critical, 1 Non-Critical)** – Sliced turkey, beef and salami in walk-in cooler at 49-53 degrees, sliced meat in sandwich line at 47 degrees, should be 41 degrees or below; Mold observed on chute in ice machine (corrected).

Quickshop Gas, Inc., 7890 E. Wabash Ave., **(2 Critical, 1 Non-Critical)** – observed accumulated black debris and pink/yellow slime on ice chute in ice machine; Milk, eggs, lunchmeat, bacon and cheese in walk-in cooler found at 64-65 degrees, should be 41 degrees or below.

Lawton Byrum VFW Post 972, 1111 Veterans Square, **(2 Critical, 0 Non-Critical)** – Observed lights off, beans on stove and in warmer and no one in charge of kitchen; Ham pieces observed on slicer, spoons with food left on counter, pots left in sink to wash.

Park Avenue Diner, 2697 E. Park Ave., **(1 Critical, 5 Non-Critical)** – No sanitizer on premises.

The Bush, 932 Locust St., **(1 Critical, 2 Non-Critical)** – Hard water mineral deposits on ice chute in ice machine.

Coyote Club, 121 E. Paris Rd., **(1 Critical, 1 Non-Critical)** – Spray bottles containing toxic substance not labeled.

Anthony Square Apartments, 400 College Ave., **(1 Critical, 0 Non-Critical)** – Observed bare hand contact.
