Lone Star Steakhouse & Saloon, 3060 S. U.S. Hwy. 41, **(5 Critical, 3 Non-Critical)** – Found sliced and shredded cheese, ribs, rice, and shrimp in cooler by grill at 54-80 degrees and eggwash at 55 degrees, all should be 41 degrees or below; Various soups in walk-in cooler not marked with date of consumption; Found dirty knives on knife racks in food prep area; Observed accumulated black debris on soda nozzle at bar; Found dead flies inside of ice machine on ice chute.

M. Moggers Brewery, 908 Poplar St., **(4 Critical, 6 Non-Critical)** – Cooked corned beef, ham in top coolers at grill 54-58 degrees (discarded); Cooked beef in walk-in cooler and baked potatoes not marked with date of consumption; Soda fountain nozzle in bar observed with mold; Discarded whipped cream observed in handwash sink in bar.

MCL Cafeteria, 3 Meadows Ln., **(4 Critical, 2 Non-Critical)** – Employee observed assembling cobb salad with bare hands; Raw chicken 61 degrees, salads and melons on line at 61-66 degrees on top, should be 41 degrees or below; Gravy for dressing left out all night at 91 degrees; Soda fountain nozzles in “to go” area found with mold.

Cheeseburger in Paradise #5505, 3830 S. U.S. Hwy. 41, **(3 Critical, 2 Non-Critical)** – Employee observed placing chips and burgers on plate with bare hands; Soda nozzles at bar observed with mold; Standing water observed on floor over clean out pipe.

Fore Seasons Golf Complex, 500 W. Honey Creek Dr., **(3 Critical, 1 Non-Critical)** – No proof of certified food handler; Baked potatoes held beyond date of consumption (discarded); Debris observed on chute in ice machine in retail store.

Kentucky Fried Chicken, 2000 Lafayette Ave., **(2 Critical, 3 Non-Critical)** – Ice chute in machine cracked and broken; Sheet pans observed with accumulated food debris.

Giovanni’s Pizza, 1532 Wabash Ave., **(2 Critical, 2 Non-Critical)** – Found two pans of lasagna on top of pizza oven at 119 –123 degrees, should be 135 degrees or above; Observed ice, wiping cloth, straws, cup and trash in handwash sink.

Jiffy Mini Mart, 1110 N. Fruitridge Ave., **(2 Critical, 1 Non-Critical)** – Observed accumulated black debris inside of ice machine; Found bucket of water in handwash sink.

Joy’s Restaurant, 1001 W. U.S. Hwy. 40, **(2 Critical, 1 Non-Critical)** – Sausage gravy, beef roast, baked potatoes, and green beans not marked with date of consumption; Observed a pan in handwash sink.

Tumbleweed Southwest Grill, 2433 S. 3rd St., **(1 Critical, 3 Non-Critical)** – Observed black debris inside of ice machine and on soda nozzles in kitchen.

West Terre Haute Mini Mart, 1160 W. U.S. Hwy. 40, **(1 Critical, 1 Non-Critical)** – Plastic tub observed in handwash sink.

Speedway #8533, 2135 Wabash Ave., **(1 Critical, 0 Non-Critical)** – Found black debris on soda fountain nozzles.

Rainbow Snacks, 3401 S. U. S. Hwy. 41, Unit D-5, **(1 Critical, 0 Non-Critical)** – Prepared food in refrigerator not marked with date of consumption.
