**Ulloa's Market Place**, 1420 Lafayette Ave, **(3 Critical, 4 Non Critical)**-Tamales not marked with date of consumption; Found rags hanging on hand wash sink; Refried beans held past date of consumption.

**Taj-Mahal**, 1349 S 3<sup>rd</sup> St, **(3 Critical, 2 Non Critical)**-Live roaches observed in dish wash area, shelves in prep, and dining room; Raw chicken stored above yellow dal and cooked spinach. Raw lamb and chicken curry stored above sauces; Tandoori chicken, sauces, cubed chicken, rice in walk in not marked with date.

**Subway #1767**, 1120 Wabash Ave, **(2 Critical)**-Debris observed on drive thru and lobby soda nozzles; Various lunch meats and cheeses in walk in cooler found at 48-55 F, should be 41 F or less.
