Cracker Barrel Old Country Store, 429 E. Margaret Dr., **(4 Critical, 5 Non-Critical)** – Grinder blades, cornbread pans, mixer bowls, and other dishes throughout the kitchen found dirty; Observed accumulated encrusted black debris on baked potato pans; Poached egg pans not washed to specified frequency, must be cleaned every 4 hours; Handwash sinks found with excessive mineral deposits.

Outback Steakhouse, 3700 U.S. Hwy. 41 S., **(4 Critical, 2 Non-Critical)** – Found dirty knives in knife rack; Baked potato pans found with accumulated burnt on black debris; Several handwash sinks found dirty; Found wiping cloth and knife in handwash sink in dishwasher area and bar handwash sink found a fork and knife.

Steak N Shake, 2900 S. 3rd St., **(4 Critical, 1 Non-Critical)** – Observed employee at drive thru handle money and put on gloves without washing hands; Employee observed dressing sandwiches with bare hands; In walk-in found spaghetti, cole slaw, and baked beans not marked with date of consumption; Soda nozzles in drive thru found with debris and ice machine had pink debris on underside of lid.

T.K.'s Sports Grill, 724 N. Fruitridge Ave., **(3 Critical, 0 Non-Critical)** – Raw meats stored on shelf over buns and shredded cheese in cooler(corrected); Potato soup in crock pot at 112 degrees, should be 135 degrees or above (corrected); Outdated Italian beef observed in walk-in cooler.

Hardee's #1500212, 200 N. 3rd St., **(2 Critical, 4 Non-Critical)** – Spanish rice and guacamole not marked with date of consumption; Plastic containers and sheet pans observed with greasy film and accumulated food debris around edges.

Pizza City #27, 315 N. 2nd St., **(2 Critical, 2 Non-Critical)** – Observed employee handling ready to eat foods with bare hands; Pre-portioned meat, soups, pasta, deli slices, etcetera. in reach in not marked with date of consumption.

Taj-Mahal, 1349 S. 3rd St., **(2 Critical, 1 Non-Critical)** – No certified food handler on staff; Pink debris observed on chute in ice machine.

Wolfe's Terre Haute Auto Auction, 1717 E. Margaret Dr., **(2 Critical, 1 Non-Critical)** – At salad bar found deviled eggs at 68 degrees, should be 41 degrees or below; Observed ice in handwash sink.

Stuckey Pecan Shop, 9950 S. U.S. Hwy. 41, **(2 Critical, 0 Non-Critical)** – Employee preparing sandwich with bare hands; Observed employee touching face and handling money without washing hands, then switch gloves.

Tokyo, Inc. – Jade Garden, 3375 S. 3rd Pl., **(1 Critical, 6 Non-Critical)** – Garlic in oil at 77 degrees, should be 41 degrees or below.

Harry & Bud's European Cuisine, 1440 S. 25th St., **(1 Critical, 2 Non-Critical)** – Cheese and salami in small cooler 51-54 degrees, should be 41 degrees or below.

Sam's Steakhouse, 2324 S. 3rd St., **(1 Critical, 2 Non-Critical)** – Macaroni salad and cooked rice not marked with date of consumption.

Burger King #5804, 2116 Lafayette, **(1 Critical, 1 Non-Critical)** – Orange debris observed on chute in ice machine.

Papa John's Pizza, 4842 U.S. Hwy. 41 S., **(1 Critical, 1 Non-Critical)** – Observed accumulated burnt on black debris on pizza pans.

Fontanet Tavern, 11150 Gallagher Rd., **(1 Critical, 0 Non-Critical)** – Items washed at 3-Bay in bar are being rinsed after sanitized and not before.

Burger King #12490, 4790 S. U.S. 41, **(1 Critical, 0 Non-Critical)** – Observed debris on lobby soda fountain nozzles.

Casey's General Store, 819 W. National Ave., **(1 Critical, 0 Non-Critical)** – Observed pink and black debris on inside of ice machine.
