Re: 2018 Budget

A timeline for the 2018 budget process has been established and we are requesting the proposed budget submissions for the 2's, 3's & 4's be submitted by **Friday, June 9**, **2017**. The Auditor's Office will be providing you with documents to submit your budget in the near future. Please scan and save a copy of your completed budget documents to your department folder on nas2. If you choose to submit hard copies of your proposed budget, please provide a copy for both the Council and Auditor.

For the departments that are outside of County General, please complete the Form 2 or Estimate of Miscellaneous Revenues first. It is important to structure your operating budget within the available revenue stream. It is advisable for you to base the revenues on at least two (2) years of historical data while accounting for any legislative or policy changes for a more accurate estimate.

For the funds that have a property tax levy please be advised the property tax cap losses continue to increase and should be considered when determining the proposed budget. A copy of the tax cap losses for 2017 and the Cash & Investments Combined Statement from the 2016 Annual Financial Report for Vigo County have been attached for your review and to provide you with insight to the challenges of the 2018 budget.

The committee is requesting a detailed written explanation for significant increases in line items as well as proposals for new projects and capital improvements to be included with the budget submission. The explanation for projects and capital outlays should include the following:

- Cost estimates
  - Potential benefits
  - Need (legislative requirement, safety, etc.)
- Funding source

The Personnel Committee will be providing recommendations to the Annual Budget Committee at the June 20, 2017 council meeting for compensation and job maintenance review requests. The recommendations will be considered along with the proposed budgets, changes in benefits costs, estimated revenues, and estimated property tax cap losses to determine the compensation package that is sustainable.

The Annual Budget Committee has tentatively scheduled department hearings for the week of July 10<sup>th</sup>. A schedule will be determined at a later date and you will be notified.
