

**Establishment Inspections**  
**April 28, 2008 through May 2, 2008**

**Kroger J-911**, 2140 Ft. Harrison, **(5 Critical, 2 Non-Critical)** –Packaged meat and cheese and other deli items 48-53 degrees in open faced cooler and island cooler, should be 41 degrees or below; Chubs of deli meat and cheese incorrectly date marked; Bread pans and icing tips observed with accumulated food debris in bakery; Meat/Cheese slicer in deli and knives in produce not broken down and cleaned every 4 hours; Waste from grease trap observed flowing onto floor in bakery.

**Valley Grill**, 2170 N. 3<sup>rd</sup> St., **(4 Critical, 3 Non-Critical)** – Observed manager touch cooked beef with bare hands; Cooked beef in open top cooler and eggs in north cooler found at 65-69 degrees should be 41 degrees or below (discarded); No consumer warning on menu for raw or undercooked foods; Handwash sinks found dirty.

**China Wok**, 3247 N. 21<sup>st</sup> St., **(3 Critical, 3 Non-Critical)** – Raw shrimp on counter at 69 degrees, fried chicken for stir-fry 78 degrees, cooked lo mein 63 degrees, should be 41 degrees or below; Steel bowls, square plastic food containers observed with dried food debris; Knives and food containers not being sanitized.

**Hilton Garden Inn**, 750 Wabash Ave., **(3 Critical, 2 Non-Critical)** – No certified food handler on staff for this location; Handwash sink in grill area does not have sufficient water pressure; Baked potatoes, cooked rice, soup, mashed potatoes not marked with date of consumption.

**The Copper Bar**, 810 Wabash Ave., **(2 Critical, 3 Non-Critical)** – No certified food handler on staff; Stainless steel pans and plastic bowls in basement found dirty.

**Crazy Buffet**, 4676 S. U.S. Hwy. 41, **(2 Critical, 2 Non-Critical)** – Garlic in oil found at room temperature, should be 41 degrees or below; Rice for sushi not marked with time to discard.

**Kentucky Fried Chicken**, 4400 S. U.S. Hwy. 41, **(1 Critical, 1 Non-Critical)** – Black debris on spray nozzle at 3-bay sink and inside of ice machine found with black, yellow and pink debris.
