

Food Establishment Inspections
April 21, 2008 through April 25, 2008

Golden Corral #2499, 10 W. Johnson Dr. **(5 Critical, 3 Non-Critical)** – Toppings in pizza prep cooler found at 70 degrees (cheese, pepperoni), should be 41 degrees or below; Pea salad, crab salad, tuna salad and diced eggs not marked with date of consumption; Dishes, pans and other utensils found with food debris; Pink debris found on ice machine in dishwash room, ice chute dirty in north ice machine at waitress station; Dishwasher not meeting required temperature to sanitize dishes.

Express Mart, 2951 S. 25th St., **(3 Critical, 1 Non-Critical)** – Handwash sink found dirty; Observed pink debris inside of ice machine; Found chili sauce and cheese sauce at 70 degrees, should be 135 degrees or above.

Marathon Gas & Food, 1701 S. 7th St., **(2 Critical, 2 Non-Critical)** – Under warmer fried chicken and eggrolls found at 127 – 131 degrees, should be 135 degrees or above; Observed black debris on soda fountain nozzles.

Glenda's Place, 230 Paris Ave., **(2 Critical, 1 Non-Critical)** – Handwash sink in bar next to 3-bay sink found unclean; Ice machine has pink/brown debris on grate in back.

Buffalo Wild Wings Grill & Bar, 3718 U.S. 41 S., **(2 Critical, 0 Non-Critical)** – Found chicken in open top cooler at 85 degrees, should be 41 degrees or below (discarded); Found old food debris on lemon slicers, tomato corer and dry rub containers.

DADC West Cafeteria, 1800 N. Fruitridge Ave., **(1 Critical, 2 Non-Critical)** – Ice/water machine in dining room had debris and/or mineral deposits on chute, perimeter of soda nozzles found unclean.

Cinnabon #235, 3401 S. U.S. Hwy. 41, **(1 Critical, 0 Non-Critical)** – Milk in under counter cooler found at 55 degrees should be 41 degrees or below.
