

Establishment Inspections

Fire Mountain, 5501 S. U.S. Hwy. 41, **(7 Critical, 5 Non-Critical)** – Employee in dish room handling dirty dishes and then putting away clean dishes without washing hands; At buffet found broccoli, fried chicken, chicken livers, roasted chicken and pork chops at 108-130 degrees, should be 135 degrees or above; Tuna salad, pasta salad on rack found at 54-59 degrees, should be 41 degrees or below; Several wiping cloth buckets found without sanitizer; At waitress stations observed accumulated black and pink debris on inside of ice machines and on inside of ice scoop holder; Pizza pans, spoons, tongs, etc. found with food debris; Handwash sink in grill area found with rag and spoon, handwash sink in bakery found with rag and food debris.

Sushi Umi, 2801 S.3rd St., **(4 Critical, 4 Non-Critical)** – Found raw eggs, chicken and beef stored over sauces and dressing; Rice at sushi bar found at 88 degrees should be 135 degrees or above; Found accumulated black debris on soda fountain nozzles; Several spray bottles containing toxic substances not labeled.

Burger King #11099, 2575 St. Rd. 46, **(2 Critical, 1 Non-Critical)** – Bacon trays, lid, and food containers found with jagged edges and no longer cleanable; Soda nozzles at drive thru found with chunks of debris.

Tee Pee Tavern, 1651 S. 25th St., **(1 Critical, 2 Non-Critical)** – Potato salad not marked with date of consumption (discarded).

McDonald's, 3032 Wabash, **(1 Critical, 1 Non-Critical)** – Lobby soda fountain nozzles found with accumulated black debris.

Burger King #13396, 1160 U.S. Hwy. 40, **(1 Critical, 0 Non-Critical)** – Observed black debris on lobby soda fountain nozzles.

Subway, 1205 N. Fruitridge, **(1 Critical, 0 Non-Critical)** – Soda fountain nozzles in lobby observed with black debris.

Family Dollar Store #2332, 1128 Locust St., **(1 Critical, 0 Non-Critical)** – Several cans of food with dents on seams observed on shelf.
