

ORDINANCE NO. 1, 2019

AN ORDINANCE VACATING A PORTION OF A PUBLIC STREET LOCATED IN OTTER CREEK TOWNSHIP, VIGO COUNTY, INDIANA.

BE IT ORDERED by the Board of Commissioners of Vigo County, Indiana:

SECTION 1. Pursuant to the provisions of I.C. 36-7-3-12, it is desired and deemed necessary to vacate a portion of a public street located in Otter Creek Township, Vigo County, Indiana, which is now laid out and existing in Otter Creek Township, Vigo County, Indiana, and described as follows:

A portion of North Otter Street as platted and laid out in Devonald's 3rd Addition in Section 28, Township 13 North, Range 8 West, Otter Creek Township, Vigo County, Indiana, as shown in the Office of the Vigo County Recorder, and more particularly described to wit:

Beginning at the Northeast corner of Lot 19 in said Subdivision, thence South to the Southeast corner of Lot 20, thence East 30 feet to the West line of Lot 18, thence North to the Northwest corner of Lot 18, thence West 30 feet to the Northeast corner of Lot 19 and the point of beginning.

Subject to all existing easements.

SECTION 2. Be it further ordained that said street in Otter Creek Township, Vigo County, Indiana, above described, be, and the same is, vacated and will revert to the abutting property subject to all existing easement rights for public utilities.

SECTION 3. Be it further ordained that the Clerk is hereby directed to furnish a copy of this ordinance to the Recorder of Vigo County, Indiana for recording, and to the Auditor of Vigo County, Indiana.



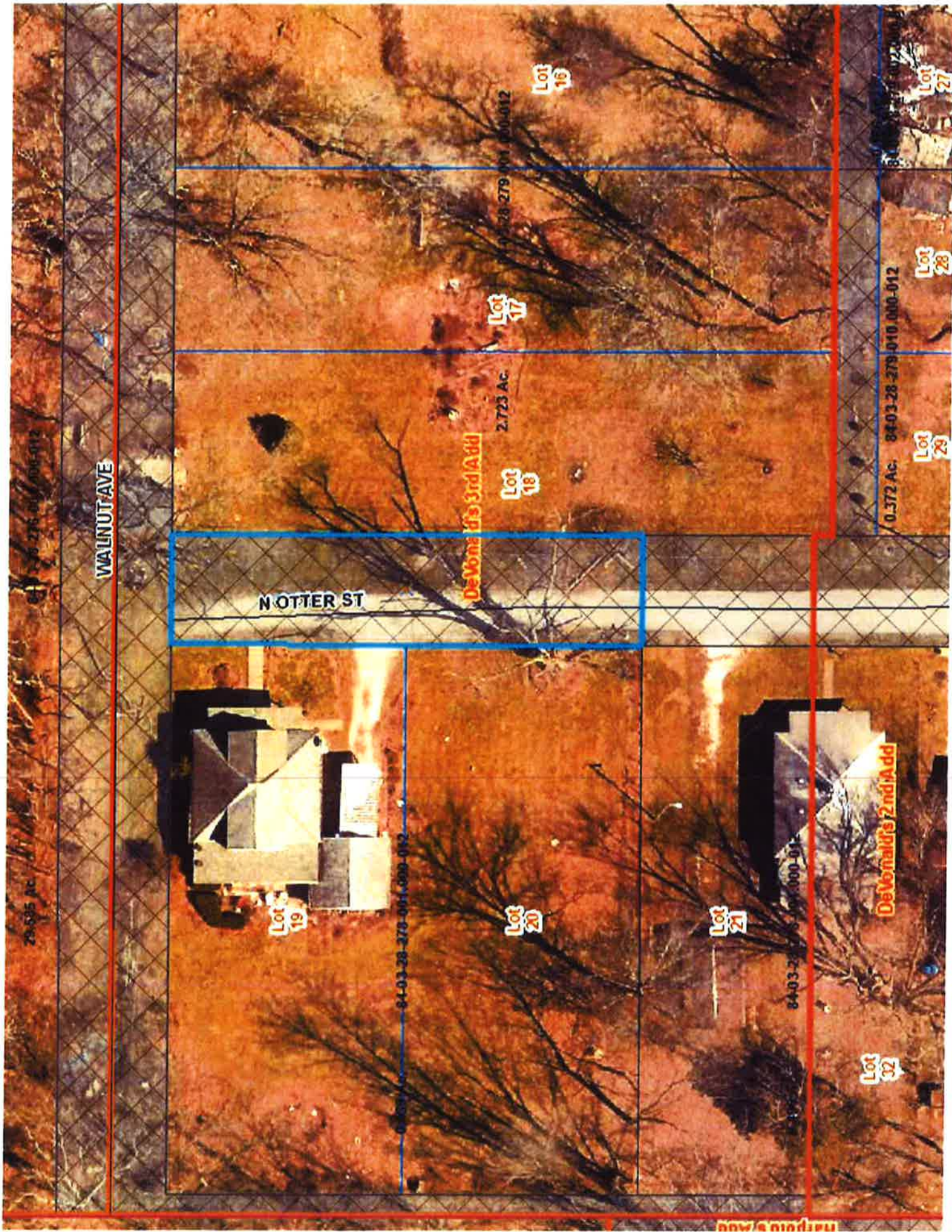
