- 5) What worse case scenarios have been contemplated? What scenario would cause WRV to cease operations? What scenario could cause a fatality or fatalities?
- 6) What accidents/emergencies/injuries/environmental incidents would be considered as part of normal and usual operations?
- 7) WRV will provide what 24/7 medical, emergency, and environmental services on-site?

What I have worked for all my life just handed to such an undeserving company owned by someone that doesn't even know my name or care that all that belongs to me will be destroyed 🍘 simply just to get rich off the backs of the people. Thank you for allowing your constituents the opportunity to provide feedback regarding the draft Community Benefits Agreement (CBA) from Wabash Valley Resources.

will preface my comments regarding the CBA by stating that I have serious concerns about the potential risks that WVR's carbon sequestration project poses to me and my children ( ages 7 months, 2 years, and 4 years).

In regards to the CBA, I have listed some comments below:

- This funding appears to be a one time contribution, whereas the intent is for WVR to inject CO2 for many years. Ongoing contributions should be made to the endowed fund for as long as carbon is injected, with a formula to determine contribution amounts and frequency.
- Consider negotiating for more money to offset lost revenue due to tax incentives provided to WVR
- Include provisions for amendment and renewal to the CBA.
- Include provisions for monitoring and remedying of environmental hazards, beyond what EPA has required. This could be for the production site, as the EPA requirements apply to the injection site.
- Include mechanisms for monitoring compliance and enforcement, and ensure that all parts of CBA are enforceable.
- State that individuals who receive benefits may not be allowed to participate in the process of administering benefits
- Further clarify and be transparent about who will qualify for benefits—and who will not.
- Per information on the Department of Energy website regarding funding programs, applicants are required to submit a Community Benefits Plan, of which a Community Benefits Agreement can be a part of. Prior to negotiating or signing a CBA please ask that the complete Community Benefits Plan be made available (preferably to the public).

- While \$3,000,000 in endowed funds, and \$5,000,000 in road funding sound like a lot, I do not believe that these amounts would go far enough.
- o In particular, the amount earmarked for first responder training and equipment seems low. In reading articles about other communities going through the same process, one comment that came up was the need for electric vehicles to respond to CO2 leaks. This is that gas and diesel vehicles would not be able to operate around a CO2 leak due to a lack of oxygen. Therefore, I find \$500k to be inadequate to provide training, oxygen tanks/breathing equipment, monitoring equipment, etc... and an electric vehicle that would allow first responders to actually respond to an emergency.

The next 2 items are likely wishful thinking, but if WVR is giving out money trying to gain support, then I will propose them.

- To protect the drinking water of those relying on private wells in the impacted area, I would like to see WVR pay for infrastructure to insure all residents living over the plume ( area where injected CO2 will spread to) will have access to safe drinking water. This could be something like paying to extend water utility mains (Indiana American Water, New Goshen Water, Etc...), so that they are accessible to residents.
- Additionally I would to see WVR provide subsidized earthquake insurance to all residents within a 3 mile radius of the injection sites.

Again thank you for allowing the opportunity to comment on this agreement. All I ask is that you do all that you can to protect the safety and well-being of my children, and the other residents of the area, from the potential risks associated with WVR's proposed project.

With the known fact that volunteers mostly support both of the fire departments listed above, Terre Haute Fire Department must be involved and should receive the same safety training and any additional equipment required. WVR will provide yearly documented training and replace any obsolete equipment as requested by the fire departments. This should include the time from startup to the projects decommissioning.
- 3- WVR- Will use the USGS as an independent third party to monitor any seismic activity and will request additional monitoring specific to this project. WVR will adhere to USGS oversight and recommendations based on this monitoring. All seismic data collected by the USGS will be available for public reviewing. This should include the time from the wells for the CSP are drilled to a minimum of 10 yrs. after the project is decommissioned.
- 4- WVR- Will supply additional air monitoring along and near the proposed pipeline. The monitoring system should have the ability to allow the community to sign up for text alert notifications to be notified should a failure happen. This should include from the time the project starts production to the project's decommissioning.
- 5- WVR- Will supply at no cost to the directly affected homeowners Water Quality Sensors and Monitors. With at least the capabilities of these parameters as indicators. Electrical conductivity and pH, and Ca2+, HCO3-, and CO2(aq) concentrations. This will include all Potable water wells currently used to supply water to their place of residency and their livestock. These monitors should provide weekly reports to the homeowner of the water condition and alert the resident of any contamination that occurs due to the WVR's project. WVR will be responsible to replace the monitor if it fails. WVR will be responsible to replace the monitor if it fails. WVR will be responsible in full cost to supply the residents with a replacement source of fresh water if a well becomes contaminated due to the WVR project. Monitoring of the Potable water wells will remove the burden of proof from the homeowner to show that the well was not contaminated before the project started. This monitoring should include the time prior to startup to a minimum of 10 yrs. after the project is decommissioned.
- 6- WVR will provide at no cost to the affected homeowners that have a Potable water supply from a ground well a Preventive Maintenance Program to calibrate and test the accuracy of the monitoring system.
- 7- WVR- Will, when any land directly affected by either the plume migration or a pipeline accident/leak from the CSP, will compensate the current landowner at fair market value of the property and for any crops lost. An independent third party assessor will perform all land assessments. This should include the time from startup to a minimum of 10 yrs. after the project is decommissioned.
- 8- WVR will, if sold, changes names or shuts downs and re-starts the CSP sooner than being down 12 consecutive months the signed CBA will be considered grandfathered and as a binding agreement between all parties.
- 9- WVR will- agree to continue using the existing CBA before the CSP process restarts after being down for longer than 12 consecutive months.
- 10- WVR will in advance on the CBA list specifically by name which roads the CSP are requesting not 90 days after execution of the CBA.
- 11- The Vigo County Commissioners should not grant non-exclusive rights to CSP of our county roads. The CSP Will-be held to the same standards/restrictions on the roadways in Vigo County as the residents.
- 12- WVR will provide a 1-week notice to request approval for any road repairs or closures.
- 13-WVR will provide to the local news outlets WTHI, WTWO and the Tribune Star and will have direct communication with the Vigo County School Board/Transportation Department on which roads will be repaired or closed. These activities will directly affect the students and residents of Vigo.
- 14- WVR will deploy in remote locations within the injection site block, permanently installed shallow bore hole fibre optic arrays. This process will provide evidence that the storage site is performing as expected against the baseline engineering and seismic data, during CO2 injection. The CO2 plume can be tracked and its migration within the formation compared against predictions and storage site expectations. In addition, WVR commits to performing 3D seismic testing to monitor the migration of the plume no less than once per year. Such modeling will be reported to each impacted household annually. Should any deviations arise, it allows proactive measures to be taken such as reducing or stopping injection or diverting injection to alternative well.

7/5/2024 I am Susan, a landowner affected by Wabash Valley Resources' pilot project. The Vigo county commissioners asked us to email our suggestions as to what we feel would be important to include in the WVR Community Benefits Agreement. I intend to leave all the decisions regarding what money the county and community foundation will get to the county elected officials, however, as an impacted resident these are the things I feel must be included in this agreement. Safety and protection of the impacted communities is my priority as you will see below and in the attached document. Since this is a holiday week and we have been placed under a July 8th at noon deadline, it is difficult to be specific in regards to the actual equipment and procedures necessary. I am not only concerned about response from the community because of the extremely limited deadline, but also because many in our area have limited to no internet access.

This is not a comprehensive list but these are some of the things that were on the forefront of my mind and I feel need to be specifically included.

I feel that the following statement and bullet points should be included as part of Wabash Valley Resources' Vigo County Community Benefits Agreement:

Any company operating at 444 W Sandford Ave, West Terre Haute, IN 47885 and/or any company owning in whole or in part, or operating any infrastructure related to this "pilot project" including but not limited to pipelines, injection wells, and any facilities associated with this pilot project will be referred to as Wabash Valley Resources for the purpose of this document regardless of their name in actuality.

Wabash Valley Resources commits that eminent domain is to be considered a last resort and is not to be pursued unless a minimum threshold of 95% of route parcels have been secured. During the meeting at Fayette Elementary, Commissioner Clinkenbeard asked about eminent domain use, Wabash Valley Resources stated they would use eminent domain "only as the absolute very very last resort" and said "that's the truth". WVR stated there would come a time when they have acquired 90 or 95% and indicated that is when they might have to resort to eminent domain. (you can find this quote in the video of the Favette meeting: https://www.voutube.com/watch?v=1dsdAhmfb4c at 00:43:15)

- Wabash Valley Resources agrees to the installation of additional seismic monitoring via USGS involvement and oversight to ensure geological stability is maintained. Since Wabash Valley Resources (WVR) is the largest scale CCS project in the USA, the USGS should monitor for micro seismic activity as they do for the smaller scale ADM facility. This can be done through the USGS Earthquake Hazards Program (EHP), which includes earthquake monitoring and hazard mitigation. WVR is required to reach out to the USGS and ask them to participate in this pilot project. WVR will ask the USGS to install a local seismic network that is monitored by the USGS. By monitoring micro quakes the USGS can ensure the integrity of the cap rock seal will not be compromised by the CCS activities. This is already being done at the ADM plant in Decatur Illinois and a similar system can be used for Wabash Valley Resources. This is especially important since our recent email conversation with the USGS where they indicated they all shared our concerns for induced seismicity is settings of geological carbon sequestration but have not been invited to participate in the Wabash Valley Resources' pilot project.
- · Wabash Valley Resources will devise, implement, and maintain tools to increase public awareness and knowledge related to the pilot project including, but not limited to: text message or other real time emergency communication alert systems; release of all seismic activity and data as per the USGU oversight; easily-accessible online materials providing pipeline, valve, and injection well locations, safety and emergency best practices, contact information, and instructions on recognizing a pipeline incident or reservoir leakage; one mailing per calendar year, at minimum, sent to local residents, elected/appointed officials representing the area, and affected landowners.
- Wabash Valley Resources agrees to provide the public with information regarding the project, including but not limited to: the anticipated route of the pipeline, a list of affected landowners, estimated construction and maintenance periods, and a list of the project's investors and shareholders.
- · Wabash Valley Resources will supply resources and materials including, but not limited to: annual emergency response training, training materials, response plans, impact zone of worst case discharge and material safety data sheets, as well as devices and equipment that assist in the preparation/detection/response to the release of carbon dioxide. This would include working with local school boards to develop, fund, and implement safety and response plans and equipment for schools located near the pipelines and injection areas.
- · Wabash Valley Resource agrees to exceed safety standards established by federal, state, and local law.
- Wabash Valley Resources agrees to provide funding for annual testing of private wells within the impacted areas.
- · In the event that Wabash Valley Resources assigns this project in whole or in part, to any person or entity, any assignee will thereupon assume any and all obligations and liabilities of Wabash Valley Resources under this agreement.
- · Wabash Valley Resources will establish and maintain a form of financial security in an amount sufficient to fund the costs of decommissioning and dismantling the pilot project at the conclusion of its scheduled operational life in accordance with the requirements of applicable federal and state laws, regulations, licenses, permits and approvals. The amount of financial security shall be revised no less frequently than every five years in order to keep pace with changes in such costs
- Wabash Valley Resources will return all easements in full once the pilot project is decommissioned without any additional court proceedings or cost to the landowner. Wabash Valley Resources will offer Landowners the option of abandoning the pipeline in place or removing the pipeline and restoring the affected land to equal or better condition. If Landowner allows the pipeline to be abandoned in place, Wabash Valley Resources will provide a one-time payment equivalent to the cost of removal and restoration.

7/6/2024 The deadline for the Wabash Valley Resources community benefits package for Vigo county has put undue restrictions on the community and directly impacted citizens by enacting overly restrictive deadlines, limited access to direct in-person commentary, and refusal to hold public meetings to inform the public and discuss the needs of the fence-line communities.

Since it has been made clear that some parties believe that open, face to face meetings about the Community Benefits Agreement would not be productive, I believe we should engage a mutually agreed upon mediator for this process as is common in situations pertaining to eminent domain and other situations with continued opposition.

Furthermore, community engagement, feedback, and input are critical to ensure a quality community benefits agreement. Since the community was not engaged for input for the first draft of the community benefits agreement their interests and concerns were not represented in the draft presented to the commissioners. To that end, it is of vital importance that all: community benefits requests, responses from the commissioners and company representatives, and a revised draft of the community benefits agreement are compiled and disclosed to the community and comments are opened for the second draft of the community benefits agreement before any such agreement is signed and implemented.

The fact that Wabash Valley Resources' pilot project will be the largest carbon capture and sequestration project in the United States makes compiling a comprehensive and specified list of necessary monitoring and protective measures for the safety of the fence-line communities absolutely imperative.

Therefore, below are modifications and additions to Wabash Valley Resources' Vigo Community benefits package that I feel, with the extremely limited analysis time given to me, are crucial to even begin to establish safety and monitoring equipment lists and procedures needed to protect our communities from Wabash Valley Resources' experimental pilot project.

COMMUNITY BENEFITS AGREEMENT REQUESTED REVISIONS:

The following should be included as points of clarification regarding the definitions of the involved parties:

Any company operating at 444 W Sandford Ave, West Terre Haute, IN 47885 and/or any company owning in whole or in part, or operating any infrastructure related to this "pilot project" including but not limited to pipelines, injection wells, and any facilities associated with this pilot project will be referred to as Wabash Valley Resources for the purpose of this document regardless of their name in actuality.

The definition of the "Project" should be amended to include the carbon dioxide facility.

WHEREAS Wabash Valley Resources is building manufacturing facilities and a carbon sequestration project to be located in Vigo County (the "Project")

The statement about the community's past and continuing support should be amended to reflect the fact that the impacted community has not and does not support this project.

WHEREAS Wabash Valley Resources recognizes the past and continued support of state legislators and some local government officials of the Project, and has agreed to provide certain community benefits;

Section 2 Training and Equipping First Responders should be amended as follows:

Section 2 Training and Equipping First Responders and Community Entities

This section should be amended to include the following:

Wabash Valley Resources shall work collaboratively with first responders serving the New Goshen, Sanford, and West Terre Haute communities. Wabash Valley Resources will fund and collaborate to create programs to train EMS workers and first responders in emergency and environmental response specific to the risks associated with Wabash Valley Resources' manufacturing facilities' operations and their carbon dioxide sequestration project.

Wabash Valley Resources shall work collaboratively with the school boards and leadership of school corporations as well as the leadership of specific schools located near Project pipelines and injection areas to develop and implement safety and evacuation education and procedures, at Wabash Valley Resources' expense, including but not limited to any such training, equipment, materials, or programs necessary to facilitate emergency preparedness and response in the event of a carbon dioxide injection well failure or event or a carbon dioxide pipeline failure or event.

Wabash Valley Resources agrees to provide equipment and devices for use in detection/response to the release of carbon dioxide to emergency response organizations as well as school corporations/schools within the vicinity of CO2 pipelines and injection wells/plumes.

Wabash Valley Resources agrees to disclose modeling of worst case discharge and failure modeling as well as safety data sheets to all emergency responders and school corporations/ schools within the vicinity of CO2 pipelines and injection wells/plumes.

Section 3 Rural Infrastructure Improvement and Use Agreement should be amended as follows:

Any and all language allowing WVR unencumbered access or expedited processes regarding land and road uses and ordinances shall be removed.

This section should be amended to include the following:

- a. Wabash Valley Resources will follow normal application, oversight, and approval protocol for performance of any roadwork or closures.
- b. After receiving approval for road repairs or closures through normal application and review procedures, Wabash Valley Resources will provide a minimum of 1-week notice of any road repairs or closures to be disclosed through their website, an opt-in text message system, and the local news stations and newspapers.
- c. Wabash Valley Resources will consult with the county transportation departments and the local school corporations concerning roads impacted by upgrades and other infrastructure implementation. Wabash Valley Resources will garner input from local school corporation leadership about the impact of project infrastructure and road use on bus routes and bus stops. Wabash Valley Resources commits to implementing suggestions from local school corporations on placement of project infrastructure, road use, and road work.
- d. Wabash Valley Resources will identify and list on the CBA the roads they intend to use for their project infrastructure and transportation needs.
- e. Wabash Valley Resources will abide by all local, state, and federal road use regulations.
- f. Wabash Valley Resources will provide a detailed list and map, including specific names, indicating the roads that will be used and improved for the manufacturing and carbon sequestration activities and infrastructure to all stakeholders including but not limited to all county citizens, school corporations, and elected officials.

Section 5 Compliance and Reporting shall be amended to include the following:

Wabash Valley Resources will engage the USGS, at Wabash Valley Resources' expense, to install and monitor a seismic network including but not limited to a system, similar in number and sensitivity to those at the ADM facility in Decatur IL, for each injection site which will record micro-quakes.

Wabash Valley Resources agrees to abide by the oversight of the USGS and follow any USGS recommendations as to the installation, use, decommissioning, and any other such recommendations the USGS feels necessary pertaining to the CO2 injections wells in efforts to maintain geological stability, maintain the integrity of the cap rock seal, and reduce the possibility of induced seismicity.

Wabash Valley Resources will make available any data gathered from the USGS and the monitoring network and make it readily available to the public in real time via their website and annually through a mailed report.

The CBA document should be amended to include the following sections and requirements:

Section 6 Public Awareness & Assurance:

Wabash Valley Resources agrees to provide the public with information regarding project status by mail prior to construction including but not limited to: the anticipated route of the pipeline on a map including identifiable markings, a list of landowners affected by the proposed pipeline route, a map which includes identifiable markings that demonstrates the location of the injection well sites and worst-case plume dispersion modeling, as well as a list of landowners affected by the injection well and plume modeling.

Wabash Valley Resources agrees to implement and sustain methods to increase and maintain public awareness and knowledge of the pilot project and its CO2 injection wells, plumes, and pipelines including but not limited to, text messages or other real time update systems for changes in construction and operational status of both the manufacturing and carbon sequestration aspects of the project, to create and maintain easily-accessible online materials as well as a yearly mailing sent to residents, elected and appointed officials, and affected landowners, detailing pipeline, valve, and injection well locations, safety and emergency procedures, instructions on recognizing a pipeline or plume/injection site

incident or leakage, as well as contact information for reporting and response to a continually monitored phone line.

Wabash Valley Resources will disclose modeling of worst case discharge and failure models as well as safety data sheets concerning any and all CO2 pipelines, injection sites, and plume areas to all landowners annually.

Wabash Valley Resources commits and agrees to exceed safety standards established by local, state, and federal law.

In light of the fact that CO2 pipeline regulations are currently under review by the federal government, Wabash Valley Resources agrees to postpone pipeline construction until federal standards for CO2 pipelines are dictated by PHMSA OR will retroactively update pipelines and infrastructure to exceed guidelines once they are set by PHMSA.

Wabash Valley Resources will establish and maintain a fund in an amount sufficient to fund the costs of decommissioning the entirety of the pilot project at the conclusion of its operational life as per requirements of all applicable state and federal regulations, licenses, permits, and approvals. Said fund will be corrected to reflect changes in such costs at intervals of no more than five years.

Section 7: Fence-line Community Safety and Protection

Wabash Valley Resources agrees to provide real-time emergency updates on the pilot project and its CO2 injection wells, plumes, and pipelines including but not limited to, text messages or other real time emergency alert systems for various points of failure in both the manufacturing and carbon sequestration aspects of the project.

Wabash Valley Resources agrees to provide corded or battery- powered emergency radios for all households within the areas of the injection wells and/or pipeline routes.

Wabash Valley Resources agrees to provide CO2 monitoring devices for all households within the area of the injection wells and/or pipeline routes.

Wabash Valley Resources commits to funding annual testing of private wells within the area of the injection wells and/or pipeline routes during its operations and will continue no fewer than 10 years following the decommissioning of the Project in its entirety.

Wabash Valley Resources guarantees to provide Safety/ evacuation equipment including but not limited to self-contained breathing apparatus equal to each individual within the household and oxygen tanks equal to double the number of individuals in the household equaling an average of 25-30 minutes of breathable oxygen each. Such apparatus and accompanying equipment will be replaced according to manufacturer labels and timelines and best practice safety procedures.

Wabash Valley Resources guarantees to provide each household within the area of the injection wells and pipeline routes with emergency kits including but not limited to items listed by the federal government via Ready.gov: flashlights, hand crank radios and a NOAA Weather Radio with tone alert, first aid kits, dust masks, and fire extinguishers.

Such safety and evacuation readiness equipment shall be offered annually to all households until the cessation of the Project and all its activities

Wabash Valley Resources will provide bottled water to any and all impacted households in the event of water contamination, scarcity, or loss in an amount equal or greater than that necessary for daily consumption such provision to end a minimum of 10 years after the decommission of Wabash Valley Resources' manufacturing and CO2 sequestration project.

Wabash Valley Resources agrees that in the event that Wabash Valley Resources assigns the Project in whole or in part to any person or entity, any assignee will thereupon assume any and all obligations and liabilities of Wabash Valley Resources under this agreement.

Wabash Valley Resources guarantees the return of all easements for their manufactured product, CO2 injection well infrastructure, and pipeline infrastructure in full subsequent to the decommissioning of the Project with no additional court proceedings, cost, or action, on the part of the Landowner.

Wabash Valley Resources will provide the landowner options to abandon in place or remove pipelines restoring the affected land to equal or better condition at Wabash Valley Resources' expense. If affected landowners opt to allow Wabash Valley Resources to abandon such infrastructure in place, Wabash Valley resources will provide a one-time payment

I am a lifelong resident of Vigo County. These are my concerns about this issue:

- there appears to be no early warning system in place for the type of industrial accidents which have occurred elsewhere. Please explore this topic in depth as relates to the proposed site and plant and plume.
- a proposed curtailing of administrative oversight at the federal level, called Project 2025, aims to reduce regulatory oversight of agencies, including the Environmental Protection Agency. What happens to the monitoring after WVR stops in 12 years? Who will monitor the wells and pipelines? In addition, the recent Supreme Court decision affecting federal agency oversight is also an unknown factor for decades-long monitoring.

I realize the focus is on economics, yet other concerns have been swept under the rug:

Mine subsidence is an unknown, which is of particular concern in an area riddled with hidden coal extraction sites. Also, affected would be soil erosion, watershed, underground acquirers, wildlife habitat, air and water quality - the company itself has already admitted, publicly and repeatedly, in August, 2023, at New Goshen, IN, the site determination was made by a man in their employ who randomly drove around the area looking for sparsely populated areas to reduce the plume effect. This process appears to be fault, incomplete and sloppy. What was the criteria for site selection?

It remains concerning that Jon Ford of the State Legislature at that time, received thousands of dollars of donation money, approximately \$25,000. He then resigned his elected position. The trust that such won't happen again with other elected has been tarnished. Where are the guardrails?

In short, there are too many unanswered questions. We are left with "damage control" and a decade-long property tax abatement.

l believe you are doing your civic duty in compliance with your public obligation as elected officials to thoroughly review this situation.

If the Wabash Valley Resources pilot program or pipeline is allowed to proceed I believe the Community Package from Wabash Valley Resources should include the list below:

- 1. Eminent Domain should not be allowed until WVR gets 95% of the land they need like they promised at the Fayette Meeting.
- 2. Installation of seismic monitoring equipment specifically for the WVR pilot project that is overseen by the USGS and monitors micro-quakes
- 3. Monitoring of seismic activity specific to the WVR pilot project by the USGS that is viewable by the public
- 4. USGS guidance will be followed to maintain safety of public well being
- 5. Trailer-mounted Fans for Forced Air Displacement for emergency responders
- 6. Air bottles to fill the SCBAs of local emergency responders
- 7. Self-contained breathing apparatus (SCBA) or SAR for emergency responders and effected schools
- 8. Air compressors and other components to fill SCBAs locally at Fire Departments in effected area
- 9. Any other PPEs need by first responders to be protected from CO2 exposure will be provided
- 10. CO2 or Oxygen monitors for emergency responders, households, and schools effected area
- 11. any needed HVAC modifications to schools effected such as CO2 monitoring on air inlets, emergency closures on air inlets to stop CO2 ingestion, and changing locations of air inlets to prevent CO2 ingestion
- 12. WVR will NOT have control of roads
- 13. WVR will NOT be given expedited permits or privileges in governmental due process
- 14. Electric Vehicles for emergency responders with charging units installed

- 15. WVR will create training for rupture and leak emergencies. They will provide all necessary equipment for schools, first responders, and other organizations along the pipeline route and in the injection/plume area

- 1. Wabash Valley Resources should keep their promise and not use eminent domain until they have 95% of the property they need.
- 2. WVR has to have the USGS come in and oversee their operation. They have to listen to what the USGS recommends and follow their advice to monitor for micro-quakes and adjust what they're doing to stop bigger ones.
- 3. All first responders, Fire stations and ambulance services should have at least one electric fire truck or ambulance and charging stations.
- 4. All EMS facilities and fire stations should have at least one electric charging station.
- 5. All the surrounding areas should have CO2 detection apparatuses that feed directly into warning towers that will send everyone alerts.
- 6. Signs should be on every telephone pole two feet off the ground along any pipeline routes carrying all of the stuff this company makes.
- 7. All houses and businesses near the pipelines and dumps should have CO2 detectors.
- 8. All houses and businesses near the pipelines and dumps should have PPE that would sustain life during a CO2 leak or rupture.
- 9. WVR and the emergency responders should have emergency response teams that specialize in CO2 on call 24/7.
- 10 The commissioners should have control over the roads

- 11. WVR should have to go and get permits for anything they need to do on the roads or anywhere else just like everybody else has to.

- 18. Once PHMSA guidelines are created WVR needs to exceed their safety standards.

- 1. All safety measures and input should be collected, devised, and implemented prior to the start of this project.
- 2. The USGS must be involved directly with the WWR pilot project. WWR cannot just use national monitoring. The USGS must oversee and monitor this pilot project specifically like they do at ADM in Illinois. The community will feel much safer if a national organization has oversight. WWR must listen to the advice of the USGS and should cease operations if the USGS feels it is necessary or beneficial to limit the possibility of induced earthquakes. This monitoring data should be available to the public.
- 3. WVR should keep the promise they made to the community at the Fayette Elementary meeting and agree, in writing, that they will not use eminent domain until they have acquired 95% of all land they need for their pipelines, injection sites, and plume areas.
- 4. WVR should pay for electric fire trucks and other electric emergency response vehicles for both counties.
- 5. Electric charging stations should be provided for emergency response personnel in both counties with the electric bills paid for by WVR.
- 6. WVR should have a dedicated 24/7 emergency response team that they train and pay on standby at their plant to respond to any emergency involving their pilot project and any of its pieces.

- 7. Alarms should be placed throughout the two counties that send text-message alerts as well as set off sirens in the event of a rupture or a leak.
- 8. WVR should place windsocks along the pipeline route and provide one for every home in the impacted areas.
- 9. Carbon Dioxide monitors should be provided to the schools and homes in the impacted areas at WVR cost.
- 10. WVR should have to work with the school corporations to make emergency response and evacuation procedures in case of a CO2 rupture, leak, or other incident related to their operations. WVR should be responsible for training and equipping teachers and staff at the schools to prepare them in case of emergency.
- 11. This should include things like breathing apparatuses enough for all children and personnel at each school, as well as enough water, flashlights, and emergency food to sustain each individual for a month
- 12. WVR must involve the school boards and superintendents to decide what supplies and resources the schools need and WVR will supply them at no cost to the schools. WVR must also allow the schools to have input on the pipeline routes to protect buses and children.
- 13. WVR should send out mailers to each household in the community prior to construction including maps of proposed pipeline routes, well sites, and plumes, and informational fliers that disclose all materials traveling in the pipes and informing the public of all potential dangers. Fliers will continue to be sent to all households no less than once per year.
- 14. WVR must hold regular informational meetings with the public to inform them about the progress of the project and their operations prior to and after construction and startup.
- 15. WVR must maintain transparency about their operations and tell people in the community what is being created at the plant, what is being piped through the community, what roads they intend to use, and any and all changes they intend to make through regular mailings prior to and during operations.
- 16. WVR will bury the pipelines deeper at a minimum 10 feet.
- 17. WVR will pressure test the pipelines to 1.5x the pressure they intend to use before injection begins.
- 18. Soil testing and core samples should be done bi-annually, and results must be made public. Sampling should be completed at multiple places around the injection site and along the pipeline routes. WVR will also pay for soil testing for all residents prior to the start of the project and will continue to pay for yearly soil testing for those in the impacted areas. This testing will continue until the company has been out of operation for 10 years.
- 19. WVR will pay for water testing for all residents prior to the start of the project and will continue to pay for monthly water testing. The testing will continue until the company has been out of operation for 10 years.
- 20. Monitoring of the plume should be continuous and the live results available to the public. WVR should use atmospheric monitors, near surface monitoring techniques (used to measure CO2 that extends from the top soil zone to groundwater zone), and 3D plume modeling. These results should also be mailed to each citizen of the counties yearly.
- 21. WVR will pay to upgrade the communication systems, internet, cell service to support emergency alert systems and information availability.
- 22. WVR will assume full liability for any sinkholes that occur in the plume area or along the pipeline routes.
- 23. Worst-case scenario disaster modeling and emergency response planning for situations including but not limited to CO2 leaks, pipeline ruptures, induced earthquakes should be done at WWR's expense, and the modeling should be disclosed to each resident of the county via mail.
- 24. After the project is completed, WVR will return all easements acquired for their project to the landowners with no cost and no action on the part of the landowners.
- 25. After WVR stops operating, landowners will have the choice about what happens to the pipelines and other infrastructure on their property. Landowners will choose to either: 1. have WVR remove the pipelines and other project pieces and restore the land to the same or better condition at WVR's cost or 2. Have WVR abandon the pipelines in place. If landowners allow WVR to abandon pipelines and other infrastructure in place, WVR will provide the landowner with a one-time payment equal to or greater than the cost to remove the pipelines and other project pieces and restore the land to the same or better condition.
- 26. WVR must wait to construct and inject until PHMSA guidelines are in place and their construction must exceed the new PHMSA guidelines.

7/10/2024 Any simulations of emergency responders working under a blanket of pure CO2? I don't think WVR can back up there is any scientific proof that the methods would work in a pure CO2 environment

I don't think anyone has tried breathing with scuba gear in a pure CO2 atmosphere. 7/13/2024 Thank you for extending the time for community comments about the CBA offered by Wabash Valley Resources to the Vigo County Commissioners. I understand the Commissioners feel their "hands are tied" on this project, but providing for the protection of our communities MUST be a priority for those of you we have elected to represent us, the local residents. I DO NOT support the pipeline and sequestration part of WVR's project and hope we can stop it from happening in Vigo and Vermillion Counties.

My home is located just over a mile away from the proposed injection site in Vigo County. My family will be living with the CO2 plume under our home and within a quarter of a mile from the CO2 pipeline that will go to the Vermillion County injection site. It was just under a year ago that I received the letter from the EPA about the Class VI Well Permit WVR was trying to obtain. This was the FIRST I ever heard that sequestration was a part of the anhydrous producing plant at the old Destec facility. There was ZERO community outreach by our state legislators, by Wabash Valley Resources, or our county officials who were aware of this project since 2016 (As stated at the July 2nd Vigo Commissioner's Meeting). Wabash Valley Resources met with impacted residents at the Union Hall in Vermilion County and a meeting at Fayette School where they promised to have more public meetings to provide answers to our questions and detailed safety measures that would be taken. There have not been any more PUBLIC meetings or outreach with the affected community. They also should be held to their promise by Rory Chambers, to not use eminent domain unless they have acquired 90 - 95% of landowner's permission.

As stated in the CBA, I DO NOT believe that Wabash Valley Resources:

\* is committed to enhancing community safety, protecting the natural environment, and enhancing community welfare as an integral part of its operations

If they are committed to these things, why did they have their liability limited in the bill passed by the legislature that is forcing this project on landholders in Vigo and Vermillion County? WVR stated at the Fayette meeting they did not want to be bothered with frivolous lawsuits. They are not responsible for any damage caused to our homes, wells, or if our property values go down and insurance rates go up. For public safety:

1. The Commissioners should demand that WVR invite and pay for the USGS to have project specific monitoring and oversight at the well injection sites and surrounding plume areas in Vigo and Vermillion Counties as ADM has at their Decatur, IL carbon sequestration facility. There is evidence that seismic activity can be increased due to the CO2 being injected at such high pressures. Seismic activity, even at low levels, can cause the capstone that would protect our water supply to develop cracks that would allow the sequestered CO2 to escape. With the addition of the 11 miles of CO2 pipeline along with the existing pipelines in our area, seismic activity also puts our community at higher risk from pipeline ruptures.

2. The commissioners should demand that WVR's CO2 pipeline meet the PHMSA guidelines for CO2 pipelines that are currently being written. The pipeline should not be constructed before the safety standards are put in place. If they choose to construct before the standards are released, the pipeline in Vigo and Vermillion Counties should not be 'grandfathered in". They MUST meet PHMSA standards to safeguard the community.

3. The commissioners should demand an emergency alert system be installed by WVR to immediately notify all local first responders, Vigo and Vermillion County Government Response Teams, the Vigo and Vermillion County School Corporations, and ALL local residents within a 5 mile radius of the CO2 pipelines in the event of ANY pipeline failure (rupture, leak, loss of pressure) or failure at the injection sites. This should include both text messages and audible sirens throughout the impacted areas. Since cell service and internet reliability is lacking in the impacted rural communities, WVR should be responsible for upgrading these services to assure the community's safety. The people of Satartia, Mississippi were not notified and want other communities to be aware of the dangers.

4. Before the commissioners consider signing any CBA, they should be provided with WVR's "worst case" scenario disaster plans for our community. With the number of underground mined areas, even small changes is seismic activity can trigger sinkholes. These plans need to be made available to the public. WVR's disaster team should be required to be the first on site (24 /7 availability) to coordinate emergency services, provide electric vehicles to rescue families nearest to the disaster site, and breathing apparatus for all families to have in their homes in case of an emergency. They should also provide plans for safeguarding our elementary schools in the impacted areas. This needs to include plans to shelter students in place, practice CO2 drills, and provide breathing apparatus for all students. WVR should also be required to pay for water testing for all impacted residents' wells and community water supplies before, during, and after injection of CO2 begins.

\*WVR recognizes the community's past and continuing support of the Project

The only support of WVR's Project is that of the labor unions, government officials, and farmers who believe having a local anhydrous supply would be beneficial. (A CO2 Pipeline and Sequestration Project is NOT required to operate an anhydrous production facility.) Landowners, who have been stripped of their private property and mineral rights, have NEVER supported the CO2 Pipeline and Sequestration portion of the project.

1. To be fair to the taxpaying landowners in the impacted community, this blanket statement of support needs to be changed to include the landowners' opposition to WVR's dangerous pipeline and sequestration pilot project. Signing a CBA with this statement would be tantamount to fraud since commissioners and WVR are aware of the opposition to this project by impacted community members.

I ask that you do not give up your local authority to WVR as to closing down roads and allowing WVR to determine which roads they damaged and what they will repair. Five million dollars covers about 5 miles of roads. Please think about the number of semis on our county roads during the construction phase, hauling in pet coke, and hauling out anhydrous ammonia. I hope you are looking at the safety of those trucks also. I shudder to think of an accident like the one in Teutopolis, IL that claimed the lives of 5 people and affected the health of several others, happening on IN-63, Third Street, or National Avenue.

Thank you for considering my concerns and opposition to this project. I hope you will read some of the information at the links I included. I must state again, I believe the blanket statement about the community support needs to be changed to include the impacted landowners' opposition to the pipeline and sequestration in our community. The safety of the community must be a priority. I do not believe WVR wants to be a part of our community. They have not been transparent or honest with those of us who will be negatively impacted by this project. WVR is here to get as much government money via grants and Q45 credits, and leave the community to deal with the fallout long after they are gone.

Your hands are "not tied" in regard to this agreement. There should not be a rush to enter into an agreement if WVR truly has community safety as a goal. You can insure the protection of the impacted community by your actions and changes to this CBA. I hope you will do the right thing for all community members, unlike our state officials.

As the board president of the Town of Universal, I suggest that you do not take any action at this point on the Community Benefits Agreement (CBA) with Wabash Valley Resources. All stakeholders and residents need to discuss this agreement more in detail and publicly and studies need to be done.

This is unchartered territory in the U.S., and local government officials need to demand that further studies be done concerning the CBA.

We need a study done on the cost of emergency preparation and response to any disasters that could occur from WVR's carbon sequestration project. One firetruck cost at minimum \$500,000. We will need electric vehicles, protective gear, seismic monitoring systems, and who knows what else. 7/14/2024 Commissioner's, Wabash Valley Resources Community Benefit Agreement will not give the community directly impacted what must be included by this company to insure Health, Safety and Monitoring Equipment. All of this should be part of the company's plan already to operate as a concerned business for our community. Instead, this company (WVR) wants to give you our Vigo County Commissioners the power to agree with this plan and sign off as community involvement.

Wabash Valley Resources Pilot Project has only engaged in two public meetings with the directly impacted community just after the August 2023 EPA meeting. At the EPA meeting everyone attending heard for the first time the name Wabash Valley Resources Pilot Project, CO2 injection wells and site locations. Comments made by those attending from our community pertained to our area having been heavily mined, seismic activity, and harm to our families, and wildlife returning to the area.

Since the two public meetings Wabash Valley Resources has failed to engage with any meaningful meetings with our community. In the July 2,2024 Commissioners Meeting our group Concerned Citizens Against Wabash Valley Resources were asked by Tammy Allen from your office, "where were we in 2016 when this was happening". The statement shows contact with Wabash Valley Resources and those in the Commissioner's office at that time and till now has been on going and leaving out the community directly impacted.

November 2023 a small group of us met with Mark Clinkenbeard giving him needs for Health, Safety, and Monitoring Equipment. This list was to be given to Wabash Valley Resources with intentions of a meeting with the community. We have never received a reply and we have asked.

June 28, 2024 Wabash Valley Resources presented to the Vigo County Commissioners a Community Benefits Agreement asking for their signatures as representing the community. Giving a deadline of July 8,2024 to have it signed. Not everyone in our community has reliable internet, or internet in many homes in our community as many do not have an email or subscribe to the paper. Wabash Valley Resources claims their website hasn't received comments or questions. Interaction should be with the community directly impacted using the internet for communication will not reach everyone in our community. Giving the community till July 15,2024 doesn't provide sufficient time for everyone involved to respond by email to you our commissioners. Not having a public meeting in our community is again private conversations with Wabash Valley Resources and not with those directly impacted leaves us out yet again.

Wabash Valley Resources Pilot project is circumventing The Department of Energy requirements for Federal Funds. It states companies receiving Federal Funds must engage with the community directly impacted. This has not been the case for WWR. This should be a priority for WWR instead of an avoidance. Using you our Commissioners to state they have would be an injustice to us the ones who are affected by this project.

There is nothing in that Benefits Agreement addressing our list of needs. We asked for WVR to have USGS monitoring for micro seismic activity which is used in the ADM plant in Decatur, IL. We showed the letter from USGS stating the concerns they had for our area. This was immediately turned down by Greg Zoeller, Vice President Wabash Valley Resources, as unnecessary. This from the former Attorney General of Indiana not open to discussing with us his decision.

This letter was included in the minutes July2,2024 Commissioners meeting.

Wabash Valley Resources should not benefit by using this presentation of its Community Benefits Agreement to you our Commissioners to sign. This company has nothing to give us in its present contents that address the Health, Safety and Monitoring Equipment we have asked. They have eminent domain over our homes, school and farmland. They also have limited liability granted by our Legislators. Wanting to give this money to the Wabash Valley Foundation to use on their discretion will not meet our needs or concerns.

I ask for the Vigo County Commissioners to stand with those in our community directly impacted by Wabash Valley Resources Pilot Project to say no and not sign this Agreement.

## 7/14/2024 To whom it may concern:

Water is our most precious resource and unlike air, contaminations to our water system are not easily corrected. Any damage done to our aquifers will be long-lasting both in terms of environmental impacts and the negative impacts on the health of our communities. WVR has presented us with no plan to correct anything that might go wrong with our water and no plans to protect or respond to any other disaster or problem that might arise. Instead, they are trying to push responsibility off on EMS responders, the fire department, and citizens who are not trained and cannot be trained to adequately respond to all the things that WVR will be producing. Nor should they have to. Chemical companies have always had teams that were responsible for protecting the environment when something happens. WVR should have to create and maintain a team at their plant to respond to any emergencies that arise whether it occurs on their plant site, along their piepleines, at the injection site, or within the plume. Asking WVR to have the same types of safety and response procedures in place as other chemical operations is not too much to ask. They are the ones who should be responsible for protecting the environment and the people; they are the ones bringing this here. WVR should have full responsibility and liability for any emergencies or disruptions caused by their operations and CO2 wells and pipelines. WVR and any other company they sell or assign this project to, should be fully liable for anything to do with their pilot project and citizens should retain the right to sue them for damages.

WVR's plan requires them to break through the consolidated slate bedrock to pump waste below our aquifer which will spread for miles. That means there are miles of opportunity for the CO2 and any contaminants to be pushed up through the unconsolidated materials and into our water supply. As the CO2 seeps through the rock, it picks up heavy metals and other contaminants that will work its way to the aquifer and ultimately contaminate our supply. Not only do the leaching of heavy metals and leaking CO2 threaten our aquifer but it is also threatened by the very saline that WVR is pumping into. When the saline is displaced, it will be forced out and upward into our water supply either through the unconsolidated rock or by following the pipes that they have pushed into the bedrock. There is no way to keep the salt out of our aquifer, and once the water is contaminated there is no going back. WVR must be held accountable for the risk they are posing to the water supply for our communities.

This project must be viewed in terms of risk versus reward. There are a lot of immediate and long-term risks that must be shouldered by our community and no benefits. We will be left with nothing more than the cost. Once this company gets what they want and they leave, we will be dealing with this for the rest of our lives. The intent for the Clean Water Drinking Act was to protect the most precious resource that people have, water. WVR's pilot project poses a long-term threat to our water, our most important resource. Even if the unthinkable does not happen immediately, the material that WVR is pumping underground will remain a risk to our water into perpetuity. If this project is allowed through, our communities face the continuous risk that we will be left high and dry. Literally. We will be faced with the irreversible consequences that will rob us of our water, our environment, our health, and possibly our lives.

Here are the things I think should have been offered in the CBA to protect us:

- 1. WVR should have the USGS come in and monitor for earthquakes for this project specifically. The ADM plant had the USGS come in to be safe. WVR should do it too.
- 2. WVR should pay USGS to put in a specific monitoring systems for this plant.
- 3. WVR should pay USGS to monitor for microquakes to protect from bigger quakes.
- 4. WVR should have to listen to what USGS has to say and adapt their practice to follow their suggestions to protect the cap rocks containing the CO2 from fracturing.
- 5. WVR should do what they said at the Fayette Elementary meeting about eminent domain. They should promise on the CBA that they will not use eminent domain against the people of the community until they have 95% of the land they need.
- 6.WVR should provide Electric vehicles for first responders and fire departments
- 7.WVR should provide CO2 alarms for all houses and businesses
- 8. WVR should have to work with the schools and corporations near the pipelines and injection wells to plan the equipment to protect themselves and evacuate from any leaks or ruptures and pay to provide it for them.

9.WVR should put Leak detector alarms with messaging sent to community and first responders

- WVR should install alert systems like tornado sirens for CO2 leaks and ruptures.
- 11. Wind socks along the pipeline so we can see where the wind is blowing in case of a leak or rupture
- 12. WVR should tell everybody through mail what the worst-case model is for a leak or rupture and what action to take.
- 13. WVR should send out a mailing every year that shows where the plume is.

- 14. WVR should pay third party to use 3D testing or the most advanced modeling technology to track the plume
- 15. WVR should not have any control over the roads.
- 16. WVR should not be automatically approved for permits for road use, upgrades, or anything else. They should have to go through the same process as any other company.
- 17. WVR's requests should not be pushed through government processes faster than anybody else's and there should be no pressure on the commissioners or other government officials to give WVR what they want if it isn't good for the communities and does not follow the spirit of the law.

Here are questions that I want answered:

- 1. Gupta said in the universal meeting that if we didn't want this they would not build it. Is this promise going to be kept ?
- 2. Will they supply escape packs for everyone along pipeline and in plum area ?
- 3. Will the community be provided with the responses to the CBA comments?
- 4. Once they have read and responded publicly to all the comments on the current draft of the CBA will there be a comment period for the revised Community Benefits Agreement?
- 5. What will WVR do IF they contaminate our aquifer? (I know they say it won't. I want to know what they are willing to do if they DO contaminate it?)

6. How much money will be set aside to supply water if the aquifer is contaminated?

- 7. Are you going to supply electric rescue vehicles to first responders and firefighters?
- 8. Rory Chambers said WVR wouldn't use eminent domain until it was a last resort. Not until they had 90-95% of what they needed. Is this true?

9. Will you be trucking all of your products away from the plant or plan to build more pipelines and hydrogen hubs?

- 10. Will you have a third party come in and monitor for earthquakes?
- 11. If there are microquakes will you stop injecting?
- 12. If you have so much money why do you need the tax abatements?
- 13. If you don't need the tax abatements can't you give them back?
- 14. Do you recognize that the entirety of the impacted communities are against this project?
- 15. You say you are going to retrain and employ "former" coal mine workers. There are no displaced "former" coal mine workers and especially none of working age, the few that are left are retired. How are you going to train them? How will you fulfill that statement?
- 16. Will you sell pieces of your company to foreign entities?
- 17 Will you truck in CO2 from other places?
- 18 Will there be pipelines from other companies into your well sites?
- 19. You said your feedstock was pet coke, then biomass, then waste plastics, what are you really using as your feedstock?
- 20. What are you actually going to make? Anhydrous? Power? Hydrogen or mostly CO2?
- 21. When you asked for your tax abatement, why did you tell the county council you had your permit when it was not approved yet?
- 22. Aren't there greener ways of making hydrogen and fertilizer?
- 23. Why aren't you using one of the greener ways of making hydrogen?
- PS I hope you understand that these are good people that are just scared and upset. People are threatening to take there land that they have worked so hard for through intamate domain and or pump millions of gallons of poison under there homes

Wabash Valley Resources wants to use our community and manipulate the people in government to get rich quick and destroy our communities in the process. WVR has manipulated to get what they want at every turn and don't care about the risks to our communities. They are always trying to give the impression that they have community support, but that is a bold-faced lie. They have not talked to the impacted communities. They have tried to go straight to the commissioners to get signatures and approvals instead of talking to the people who will be directly impacted by this pilot project. In fact, they have not involved Vermillion County at all. They are trying to do everything out of Vigo County. Even then they haven't talked to or asked the people who are directly impacted. They are trying to use elected officials to make it out to be that they have "engaged" with the community.

These people at Wabash Valley Resources are trying to work the system and the laws the state wrote. They are trying to make you think that they have done what they are supposed to do so they can do whatever they want. Do not let them use our communities to make themselves billions.

Wabash Valley Resources has not thought about or even asked what kinds of protections the community wants in place. We haven't even had a meeting with them since last year and they cancelled the last one we had scheduled. They only wanted to meet with us when they thought we were stupid and knew we didn't have any information and had no idea what their company was going to do so we would believe their side.
