

# **CONTRACT FOR SERVICES**

Pursuant to IC 16-20-5-6 (Powers and Duties) this agreement made for the Vigo County Health Department, and hereinafter called "VCHD" and the Vigo County Parks and Recreation Department", hereinafter called the Grantee, witness that Grantee will conduct a project entitled:

## **Vigo County Parks & Recreation Department Griffin Bike Park Building Bikes Program: Chronic Disease Prevention**

### **Article 1- Service to be provided**

Grantee shall, in a satisfactory and proper manner will seek to enhance a recreational park in an effort to prevent or reduce the prevalence of health issues or improve the health and behavioral health of Indiana residents as outline in the plan described in IC 16-30-3-2; Obesity, Diabetes, cardiovascular diseases, including hypertension and hyperlipidemia. The Griffin Bike Park is a progressive riding park. The vision of the Vigo County Parks Department is to meet the recreation and leisure needs of Vigo County citizens and visitors, leading to a heightened quality of life. The mission of the Vigo County Parks and Recreation Department is to improve quality of life and provide meaningful experiences for the citizens of Vigo County through expertly maintained areas and facilities, environmental education, accessible water, and preservation of the environment allowing for recreation, social activity, exploration, and solitude.

### **Article 2- Length of the Contract**

The services of Grantee are to commence July 1, 2024 and continue through December 31, 2024, unless this contract is canceled in accordance with the provisions contained herein.

### **Article 3-Compensation**

The VCHD agrees to pay Grantee up to \$ 30,198, all of which sums are to be used by grantee and any unused funds must be returned to the VCHD. All other expenses shall be paid by the grantee without compensation by the VCHD.

### **Article 4- Retention of Records**

Records will be maintained by the Grantee to facilitate any state or federal program or fiscal audit. A bi-annual report of fiscal and program activities shall be submitted to the VCHD from by all Grantee's by July 1, 2024 and February 1, 2025. The Grantee's shall report all evaluation data to the VCHD by July 1, 2024 and February 1, 2025.

### **Article 5- Termination**

**Article 5- Termination**

This contract may be terminated by either party providing the other party receives notice in writing by registered mail addressed to the usual place of business 30 days prior to the effective date of termination.

**Article 6- Modification**

No alteration or variation of the terms of this contract shall be valid unless made in writing and signed by the parties hereto and no oral understanding or agreement not incorporated herein shall be binding on any of the parties hereto.

**Article 7- Funding**

Funds for this contract will be provided under the VCHD. Continuation of this contract is contingent upon availability of funds.


**Article 8- Failure to Perform**
